



LIMITED PRODUCT WARRANTY NON-TRANSFERABLE

Terms of the Limited Warranty

CARSHOW warrants to the original retail purchaser, that the automotive video product(s) purchased from a CARSHOW Authorized Dealer are free from defects in materials or workmanship under normal use and conditions for a minimum period of Twelve (12) months from date of retail purchase, whichever comes first. No warranty registration is required. Remote controls, headphones and game controllers are warranted for a period of NINETY (90) DAYS and iPod™ interface cables and satellite radio tuners are warranted for a period of twelve (12) months from date of retail purchase. A sales receipt or vehicle purchase contract, showing the installation date and CARSHOW product details are required to verify proof of retail purchase.

Should the product(s) be determined defective during the applicable warranty period, the defective product(s) will be repaired or replaced with equivalent reconditioned product(s), at CARSHOW's sole option. To obtain warranty service, the product(s) must be returned to a CARSHOW authorized dealer along with proof of retail purchase and warranty coverage.

Exclusions

- Elimination of externally generated static or noise, or the correction of reception problems or loss of service due to Terrestrial Radio, Satellite Radio, Phone, Bluetooth, TV, or Navigation signals.
- Costs incurred and/or loss of vehicle use for installation, removal or reinstallation of the product(s).
- Damage to video games, iPod, phones, cameras, camcorders, discs, speakers, accessories, software or vehicle electrical systems.
- Cosmetic damage or damage due to negligence, misuse, abuse, failure to follow operating instructions, accidental spills or customer applied cleaners.
- Damage or loss due to environmental causes such as floods, airborne fallout, chemicals, salt, hail, windstorms, lightning or extreme temperatures.
- Damage or loss due to accidents, road hazards, fire, theft or vandalism.
- Damage due to improper installation or connection, improper connection to equipment of another manufacturer, modification of existing equipment, use of a faulty DVD/CD or MP3 disc, cleaning of the DVD player.
- Product(s) which have been opened or tampered with for any reason or which have been damaged due to alteration or service performed by anyone other than CARSHOW.
- Bluetooth Hands-Free (if so equipped): Inability to connect, pair or to use features of a Bluetooth phone which are not supported by this system.
- iPod™ Interface (if so equipped): inability to interface, connect or use features which are not supported by this system.
- Back-Up Camera (if so equipped): damage or loss due to improper use, failure to clean the camera lens, understanding of the camera's capabilities and limitations
- Navigation (if so equipped): REFER TO THE NAVIGATION SYSTEMS OWNERS MANUAL FOR SPECIFIC EXCLUSIONS
